## V. County Business

A. **Developmental Disability Advocates** – Stacey Ismail, Executive Director and Dave Weiler, Director of Administration for Developmental Disability Advocates said they were mainly at the meeting to gauge the County Councils interest in supporting them to place a tax levy increase proposition on the August 2022 Ballot. They passed out a handout and explained who Developmental Disability Advocates is, what they do and who they help. Ms. Ismail spoke on how agency requests for funding has gone up 48% in the past 5 years. Developmental Disability Advocates has not **requested** an increase in 24 years and has not **received** an increase in 32 years.

County Executive Dennis Gannon gave an example of a man he knew who wanted to work but didn't have a way to get there. Developmental Disability Advocates set him up with transportation through JC Transit and he has been using them for 24 years to go to work.
