9 of records as promulgated by the Secretary of State.


10 Section 4. This Ordinance shall be in full force and effect from and after its

12 shall not affect the remainder of this Ordinance.





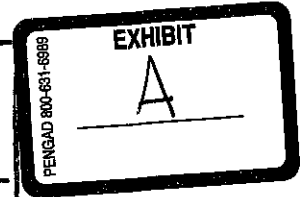
