**Proposition - (Simple Majority)**

**Arnold Community Recreation Center**

Shall the City of Arnold, Missouri construct, furnish, operate and maintain a community recreation center, including an aquatic facility and other recreational amenities, and impose, for the purpose of funding the center and its operation and maintenance, a City sales tax for local parks at a rate of one-quarter of one percent (1/4 of 1%) on all retail sales of property or services within the City that are subject to taxation by the State of Missouri under the provisions of Section 144.010 to 144.525, RSMo, as amended?

Approval of this proposition authorizes a one-quarter of one percent (1/4 of 1%) sales tax for local parks. All proceeds of this sales tax will be spent to construct, furnish, operate and maintain a community recreation center. The recreation center proposal will include recreational amenities for all age groups, including an aquatic facility, gym, walking track, fitness areas and meeting rooms.
