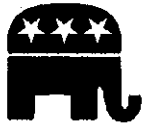

CONSTITUTIONAL AMENDMENTS

CONSTITUTIONAL AMENDMENT NO. 1 (Simple Majority)
Proposed by the 93rd General Assembly (First Regular Session) SJR 1

Shall Article IV, Section 47(a), (b), and (c) of the Missouri Constitution be amended to:

- A) reauthorize for ten years the one-tenth percent sales/use tax for (1) soil and water conservation; (2) state parks and historic sites; and
- B) resubmit this issue to a vote every ten years or at an earlier special election?

The proposed constitutional amendment continues until 2016, but does not increase, the existing sales and use tax of one-tenth of one percent that is set to terminate in 2008. The tax would generate approximately \$82 million annually for soil and water conservation efforts and operation of the state park system.

**CITY OF HILLSBORO
QUESTION**

Shall the City of Hillsboro, Missouri, issue its combined waterworks and sewerage system revenue bonds in the amount of eight million five hundred thousand dollars (\$8,500,000) for the purpose of acquiring, constructing, extending, improving, furnishing and equipping the City's existing combined waterworks and sewerage system, and refinancing existing obligations relating to the system, the cost of operation and maintenance of said system and the principal of and interest on said revenue bonds to be payable solely from the revenues derived by the City from the operation of its combined waterworks and sewerage system, including all future extensions and improvements thereto?

PROPOSITION VISION (Simple Majority)**

Shall the municipality of Pevely, Missouri, impose a sales tax of one-half (1/2) of one (1) percent for the purpose of funding capital improvements which will include the building of a new city hall, operation and maintenance of other such capital improvements?

**DUNKLIN FIRE
PROPOSITION IMPROVEMENT (Simple Majority)**

Shall the Board of Directors of the Dunklin Fire Protection District be authorized to levy an additional tax of not more than (\$0.25) twenty five cents on the (\$100.00) one hundred dollar assessed valuation to provide funds for the support of the District and the hiring of additional paid personnel? If this proposition is approved by the majority of the voters, the Board of Directors shall implement the additional tax rate at (\$0.15) fifteen cents the first year and a rate of (\$0.05) five cents per year for the next two years until said tax rate is complete.

PROPOSITION PENSION (Simple Majority)
Shall the Board of Directors of the Dunklin Fire Protection District be authorized to levy an additional tax of not more than (\$0.05) five cents on the (\$100.00) one hundred dollar assessed valuation, revenues from which shall be deposited in a special fund and used only for the pension program of the District?

**GOLDMAN FIRE
PROPOSITION (Simple Majority)**

Shall the board of directors of the Goldman Fire Protection District be authorized to levy an additional tax of not more than twenty-five cents on the one hundred dollars assessed valuation to provide funds for the support of the district, fifteen cents of which shall be levied for the year 2006 and thereafter, five cents of which shall be levied for the year 2007 and thereafter, and five cents of which shall be levied for the year 2008 and thereafter?

HIGH RIDGE FIRE
PROPOSITION LOWER YOUR PROPERTY TAX (Simple Majority)

Shall the High Ridge Fire Protection District of Jefferson County Missouri, lower the property tax levy by imposing a sales tax of one-half (1/2) of one percent for the purpose of providing revenues for the operation of the High Ridge Fire Protection District and the total property tax levy on the property in the High Ridge Fire Protection District shall be reduced annually by an amount which reduces property tax revenues by an amount equal to fifty percent (50%) of the previous year's revenue collected from this sales tax?
