SUMMARY

The Department of Public Works requested a renewal option for Automotive Parts and Supplies 2014 on February 5, 20115. A renewal request was mailed to Auto Tire & Parts Company (A1), B & A Auto Parts (A2) Factory Motor Parts (A3), Reuther Ford Inc. (A4), Weir Chevrolet & Buick GMC Inc. (A5) and Weir Wholesale Parts LLC (A6) for the Automotive Parts and Supplies 2014contract for an additional one year term on February 10, 2015 and again on March 12, 2015.

All vendors returned the renewal letters between February 23 and April 6, 2015 except B & A Auto Parts. 
