1 **AN ORDINANCE RENEWING THE BID AWARDS FOR CERTAIN**

4 **WHEREAS**, Pursuant to Ordinance 19-0173 Jefferson County, Missouri entered
5 into a Contract, known as the Heavy Truck Parts, Supplies and Repair 2019, with Clark

1 **WHEREAS**, the Department of Public Works of Jefferson County, Missouri,
2 requested renewal from the awarded bidder, Clark Power Services, Inc., O'Reilly
3 Automotive Stores, Inc DBA O'Reilly Auto Parts, Tractor Trailer Supply Co. to renew
4 the contract for the Heavy Truck Parts, Supplies and Repair 2019 with the County; and

5 **WHEREAS**, the Jefferson County Council, of Jefferson County, Missouri, finds it

16 shall not affect the remainder of this Ordinance.
